# Restoring the Foundations - Issue Focused Ministry Ministry Receiver's Data Protection Statement

King's Church is committed to discretion and confidentiality in every appropriate context and at every stage of ministry undertaken by the King's Church Restoring the Foundations (RTF) Issue Focused Ministry Teams.

All hard copy personal data and information received or recorded prior to and during the course of the ministry is securely held under lock and key unless being used to prepare, process or execute ministry.

Personal data held digitally/electronically will only be held on an encrypted hard drive, encrypted 'memory stick' - or similar encrypted device. A PC/laptop/tablet may be used to process or update that data.

After the ministry is completed, the following documents will normally be retained securely either as hard copy or digitally (as above) for the King's Church records:

- A copy of this page giving your permission for us to process and store your data (signed & dated by yourself).
- A copy of the RTF 'Waiver of Liability and Confidentiality' page confirming that you
  understand the nature of the RTF prayer ministry that you receive and the circumstances
  in which confidentiality may be waived, (signed & dated by yourself included in 'IFM
  PQ').
- A copy of the IFM 'Ministry Receiver Ministry Highlights' page, received during your ministry.
- A copy of your IFM 'Personal Questionnaire'.

These documents will be stored securely for 7 years, and then destroyed.

## **Purposes**

The personal data you provide is for the purposes of our ministry to you. It will not be passed to any third parties without your consent, save where there is a legal obligation to do so.

- In certain circumstances, have inaccurate personal data rectified, blocked, erased or destroyed and claim compensation for damages caused by a breach of the Data Protection regulations.
